### I. OVERVIEW OF COURT PROCEEDINGS

#### MLADIĆ case

*Trial Chamber I – Judges Orić (Presiding), Flügel and Moloto*

#### Initial appearance

On 3 June 2011, the accused chose not to enter a plea at this stage. A further appearance is scheduled for 4 July 2011.

#### KARADŽIĆ case

*Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)*

#### Continuation of the Prosecution case

On 31 May 2011, the following witness testified:

- *Radomir Kezunović (President of the Serbian Municipality of Ilidža during the relevant period)*

On 1 and 2 June 2011, the following witness testified:

On 3 June 2011, the trial adjourned following a Defence motion for another suspension of the trial due to alleged disclosure violations by the Prosecution. The Chamber will consider the motion in due course.
