SCHEDULING ORDER

On 23 April 2012, the Chamber noted that the Prosecution had closed its case on 20 April and ordered each accused to file written submissions, until 27 April 2012, indicating whether they intend to make Rule 98bis submissions and whether they intend to present a Defence case. Next Status Conference is scheduled to take place on 2 May 2012 at 14:15 in CR3.

DECISION GRANTING IN PART PROSECUTION’S MOTION FOR EXTENSION OF TIME TO FILE THE FINAL TRIAL BRIEF AND ORDER ON FINAL TRIAL BRIEFS AND CLOSING ARGUMENTS

On 25 April 2012, the Chamber granted in part the motion by the Prosecution and ordered that the parties would file their final trial briefs no later than 14 May 2012 and that the closing arguments would be heard from 29 May until 1 June 2012.

SCHEDULING ORDER ON CLOSE OF THE PROSECUTION CASE, RULE 98bis SUBMISSIONS, AND START OF THE DEFENCE CASE

On 26 April 2012, the Chamber ordered the following:

- The Prosecution will call its last witness during the week of 4 May 2012;
- Karadzic will present his Rule 98bis submissions a week after the close of the Prosecution case;
- The Defence will file its list of witnesses and exhibits until 27 August 2012;
- A Status Conference will be held on 3 September 2012;
- The Pre-Defence Conference shall be held on 15 October 2012;
- The Defence case will start on 16 October 2012.
