PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

KARADŽIĆ case

Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)

Continuation of the Prosecution case

On 1 and 2 May 2012, the following witness testified:

On 3 May 2012, the following witness testified:

Pre-trial Conference

On 3 May 2012, the parties met before the Chamber for the pre-trial Conference. The Prosecution's opening statement is scheduled to take place on 16 and 17 May 2012.

Status Conference

On 2 May 2012, the parties met before Judge Moloto for a Status Conference during which it was confirmed that the final trial briefs would have to be filed until 11 June 2012 and that the closing arguments would be held on 25 and 26 June 2012.

The Prosecution officially rested its case on 20 April 2012. All Defence teams indicated that they would not file motions for acquittal pursuant to Rule 98bis. Furthermore, Haradinaj and Brahimaj stated they would not present any Defence case whereas the Balaj’s Defence stated it may still present a “limited Defence case” (subject to an agreement concerning medical evidence).
