DECISION ON APPEAL OF DECISION ON REMAND OF COUNT ONE

On 12 September 2013, the Appeals Chamber dismissed the accused's appeal and found that *“the Trial Chamber correctly determined that the Rule 98bis appeal judgement made a final determination with regard to Karadžić's Rule 98bis motion for acquittal.”*
