ORDER ASSIGNING JUDGES TO A CASE BEFORE THE APPEALS CHAMBER

On 13 February 2014, Judge Agius, Acting President of the ICTY, assigned the Appeals Chamber, consisting of Judges Flügge, Sekule, Ramaroson, Khan and Afande, to consider the accused's appeal against the decision ordering the continuation of the proceedings from the closing arguments as soon as Judge Niang would be familiarized with the case records.

PUBLIC REDACTED VERSION OF "DECISION ON REQUEST BY RADIVOJE MILETIĆ TO POSTPONE DATE OF TESTIMONY" ISSUED ON 13 FEBRUARY 2014

On 14 February 2014, the Chamber decided to vacate the decision on subpoena against Radivoje Miletić, issued against him last year, in order to testify for the Karadžić's Defence. Having reviewed all the information presented in the request by Miletić, the Chamber concluded that compelling Miletic to testify in these circumstances would not serve the interests of justice.
