PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

MLADIĆ case

Trial Chamber I – Judges Orie (Presiding), Moloto and Flügge

Continuation of the Defence case

On 16 June 2014, the trial was adjourned early due to ill-health of the accused. All the subsequent hearings this week were cancelled.

HADŽIĆ case

Trial Chamber II - Judges Delvoie (Presiding), Hall and Mindua

Pre-Defence Conference

On 17 June 2014, the Pre-Defence Conference took place, during which it was announced that the Defence would need 140 hours to present its case, which will start on 3 July 2014 at 09:00. The first Defence witness would be the accused himself.

ORDER INVITING THE PARTIES TO MAKE SUBMISSIONS ON POSSIBILE PROVISIONAL RELEASE OF THE ACCUED *PROPRIO MOTU*

On 13 June 2014, the Chamber invited the parties to file submissions on possible provisional release of the accused. The Prosecution is to file its submission within seven days from the date of distribution of the decision, and Šešelj is to do so within seven days of receipt of the B/C/S translation of this decision.
