PUBLIC REDACTED VERSION OF THE 28 AUGUST 2015 DECISION OF THE PRESIDENT ON THE EARLY RELEASE OF DRAGAN ZELENOVIĆ

On 15 September 2015, a public redacted version of the MICT President's decision was filed announcing the early release of Dragan Zelenović, who was sentenced to 15 years imprisonment' for crimes in Foča, effective on 4 September 2015.

INTERIM ORDER ON ACCUSED’S REQUEST FOR STATUS CONFERENCE

On 16 September 2015, the Trial Chamber stayed its ruling on the accused's request for a Status Conference and ordered him to file written supplements, until 21 September, specifying which specific issues he wants to raise in relation to his health and detention conditions and the remedies he would seek from the Chamber on these issues.
