Initial appearance

On 29 May 2008, the parties met before Judge Lattanzi for the initial appearance of the accused Ljubiša Petković, charged with contempt of court for refusing to abide by the subpoena as a Chamber’s witness in the Šešelj case. He pleaded not guilty – *See also Press Release number 1257, dated 28 May 2008.*

DECISION ON PROVISIONAL RELEASE

On 26 May 2008, Trial Chamber III granted the Defence motions and ordered that Jovica Stanišić and Franko Simatović shall be provisionally released but stayed the execution of this decision pending appeal.

Subsequently, on 28 May 2008, the Prosecution filed its appeal against the decision.

DECISION ON POPOVIĆ'S MOTION FOR PROVISIONAL RELEASE

On 28 May 2008, Trial Chamber II denied a motion for provisional release of Vujadin Popović.

DECISION ON HARAQIJA AND MORINA REQUESTS FOR RECONSIDERATION OF SCHEDULING ORDER AND FOR CERTIFICATION FOR APPEAL

On 29 May 2008, Trial Chamber I granted the Defence motions for reconsideration of the previous scheduling order and ordered that the trial in this case shall take place between 8 September and 12 September 2008 (instead of 16-20 June).
