PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

MILOŠEVIĆ Case (“Croatia and Bosnia and Herzegovina”)

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

36th week of the Prosecution case.

From 22 until 25 July 2003, the following witnesses were examined by the Prosecution and subsequently cross-examined by the Accused and one of the *amici curiae*:

- Protected Witness B-127
- Protected Witness B-83
- Expert Witness Audrey Budding
- Witness Stanko Erstić (not cross-examined by one of the *amici curiae*)
- Witness Ivan Marjanović
- Protected Witness B-1097 (cross-examination was not yet concluded)

BRDANIN Case (“Krajina”)

Trial Chamber II Section A – Judges Agius (Presiding), Janů and Taya

44th week of the Prosecution case.
