**ELEVENTH DECISION ON APPLICATIONS PURSUANT TO RULE 54bis OF PROSECUTION AND SERBIA AND MONTENEGRO**

On 13 November 2003, the Trial Chamber ordered that the Prosecution give notice of its Motion requesting binding orders for the production of documentation to Serbia and Montenegro no later than 17 November 2003. It further ordered that Serbia and Montenegro file a response (if any) to the Motion no later than 1 December 2003.

**ORDER ON PROSECUTION’S APPLICATION PURSUANT TO RULE 54bis**

On 13 November 2003, the Duty Judge granted the Prosecution Application for an order under Rule 54 *bis* of the Rules, and ordered Serbia and Montenegro to comply with the Request for Assistance.

**DECISION ON INTERLOCUTORY APPEAL ON MOTION FOR ADDITIONAL FUNDS**

On 13 November 2003, the Appeals Chamber dismissed Dragoljub Ojdanić’s Appeal of Decision on Motion for Additional Funds *Ex Parte*, filed on 23 July 2003. Judge Shahabuddeen appended a separate opinion and Judge Hunt appended a dissenting opinion to the Decision.
