### **ORDER CONCERNING THE PROSECUTOR’S MOTION SEEKING LEAVE TO AMEND THE INDICTMENT**

On 12 January 2004, the Trial Chamber directed the Prosecution to file an Amended Indictment within three days of the Order. It granted the Defence 45 days from the filing of the Amended Indictment to make submissions on the form of the Indictment and granted the Prosecution 14 days from the filing date of any Defence filing to file a reply. The Prosecution filed the Amended Indictment on 14 January 2004. The Trial Chamber requested the Registrar to make arrangements for a further appearance of the Accused, within three weeks, to enter pleas on the counts of the Amended Indictment.
