PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

MILOŠEVIĆ Case (“Kosovo, Croatia and Bosnia and Herzegovina”)

Trial Chamber III - Judges Robinson (Presiding), Kwon and Bonomy

Fifth week of the Defence case.

On 18 October 2004, the Defence discussed issues concerning the preparation of its case and the calling of witnesses.

On 19 October 2004, the following witness was examined by the Defence counsel and subsequently cross-examined by the Prosecution:

The trial was then adjourned until 26 October 2004.

Appeals Chamber - Judges Meron (Presiding), Pocar, Güney, Weinberg de Roca and Mumba

On 21 October 2004, a Motion hearing took place. The court assigned Defence counsel, the Accused and the Prosecution submitted their oral submissions regarding the Defence appeal against the Trial Chamber decision to assign Defence counsel to the Accused. DECISION ON NALETILIĆ’S CONSOLIDATED MOTION TO PRESENT ADDITIONAL EVIDENCE

On 20 October 2004, the Appeals Chamber found that none of the additional evidence submitted by the Appellant on appeal met the requirements of Rule 115 of the Rules of Procedure and Evidence. The Appeals Chamber dismissed the Consolidated Motion, filed by the Defence for Mladen Naletilić on 8 September 2004, in its entirety.

DECISION ON MARTINOVIĆ’S REQUEST FOR PRESENTATION OF ADDITIONAL EVIDENCE

On 20 October 2004, the Appeals Chamber found that the proposed additional evidence submitted by the Appellant was inadmissible under Rule 115 of the Rules of Procedure and Evidence. The Appeals Chamber dismissed Vinko Martinović’s 15 March 2004 Motion in its entirety.
