The Applicant and representatives of the governments of Canada, The Netherlands, the United Kingdom, the United States, Germany and France presented their arguments.

ORDER APPOINTING A TRIAL CHAMBER FOR THE PURPOSE OF DETERMINING WHETHER AN INDICTMENT SHOULD BE REFERRED TO ANOTHER COURT UNDER RULE 11 BIS

On 1 December 2004, the President appointed the following Judges to constitute the Trial Chamber for the purpose of determining whether this case should be referred to the authorities of Bosnia and Herzegovina pursuant to Rule 11bis:

ORDONNANCE PORTANT LEVEE DE LA CONFIDENTIALITE DE MANDATS D'ARRET

On 1 December 2004, Judge Antonetti issued an order lifting the confidentiality of the arrest warrants directed to the authorities of Bosnia and Herzegovina on 5 October 2004 and to the authorities of Serbia and Montenegro on 7 October 2004.

ČERKEZ Case ("Lašva Valley")

Appeals Chamber - Judges Schomburg (Presiding), Pocar, Mumba, Güney and Weinberg de Roca ORDER TO RELEASE MARIO ČERKEZ

On 2 December 2004, the Appeals Chamber ordered the immediate release of Mario Čerkez from the United Nations Detention Unit (see *Press Release* No. 919). The full reasons for this Order will be given in the Judgement which will be rendered on 17 December 2004 at 2.15 p.m. in the case *The Prosecutor v. Dario Kordić and Mario Čerkez*. The Appeals Chamber considered that "*Mario Čerkez's sentence has to be revised*". Mario Čerkez was sentenced to a term of 15 years' imprisonment for the crimes of which he was found guilty by the Trial Chamber on 26 February 2001 (see *Press Release* No. 567). He has been in custody of the ICTY since his voluntary surrender on 6 October 1997.

The Prosecution filed an urgent request to stay the order of the Appeals Chamber on the same day, 2 December 2004.

ČERMAK and MARKAČ Case

Appeals Chamber - Judges Mumba (Presiding), Pocar, Shahabuddeen, Güney and Schomburg DECISION ON INTERLOCUTORY APPEAL AGAINST TRIAL CHAMBER'S DECISION DENYING PROVISIONAL RELEASE

On 2 December 2004, the Appeals Chamber granted the appeal against the 14 September 2004 Decision of the Trial Chamber denying the provisional release of the two Accused. It ordered the provisional release of Ivan Čermak and Mladen Markač under the terms and conditions set out in the Decision (see *Press Release* No. 921).

ORDER FOR THE IMMEDIATE CESSATION OF VIOLATIONS OF PROTECTIVE MEASURES FOR WITNESSES

On 2 December 2004, Judge Alphons Orie ordered *HKZ-Hrvatsko Slovo d.o.o.*, a Croatian weekly, and all its employees, "to cease publication in *Hrvatsko Slovo and in any other publications, and to desist from further publication of statements or testimonies*" of a protected witness who appeared in the Blaškić trial, as well as any other protected witness (see *Press Release* No. 920).

DECISION TO EXTEND THE ORDER FOR PROVISIONAL RELEASE
