### **ADEMI and NORAC Case**

*Specially Appointed Chamber – Judges Orić (Presiding), Kwon and Parker*

On 17 February 2005, the Specially Appointed Chamber heard arguments on whether to refer the Ademi and Norac case to the authorities of Croatia. Representatives of the Government of Croatia and two *amici curiae* participated in the hearing. The two Accused were not present. Rahim Ademi was provisionally released on 20 February 2002 and Mirko Norac is in detention in Croatia under the authority of the Tribunal.

### **Blagoje SIMIĆ Case (“Bosanski Šamac”)**

*Pre-Trial Judge Güney*

On 17 February 2005, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence.

### **TODOVIĆ Case (“Foča”)**

*Pre-Trial Judge Agius*

On 17 February 2005, Savo Todović appeared before Judge Agius for his further appearance. Pursuant to Rule 62(iv) of the Rules of Procedure and Evidence, the Judge entered a plea of “not guilty” on his behalf, as he failed to enter a plea. On 19 January 2005, at his initial appearance, Savo Todović had also declined to enter a plea (see *Weekly Update* No. 343).
