SCHEDULING ORDER

On 17 July 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54, 65*ter*, 73*ter*, 84, 85, 86 and 98*bis* of the Rules, the Trial Chamber ordered that the Defence case shall end on 24 August 2007. The order also stated that the final briefs shall be filed on 1 October and closing arguments shall be held from 8-9 October 2007.
