DECISION ON OJDANIĆ THIRD MOTION FOR STAY OF PROCEEDINGS

On 27 August 2007, pursuant to Articles 20 and 21 of the Statute and Rule 54 of the Rules, the Trial Chamber denied General Ojdanić's third motion to stay the proceedings on the ground that the purported inability of his Defence to conduct investigations of alleged crime sites or to interview witnesses in Kosovo interferes with his right to a fair trial.
