DECISION ON USE OF TIME REMAINING FOR DEFENCE PHASE OF TRIAL

On 21 November 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54 and 73ter of the Rules, Trial Chamber III ordered that the Lazarević Defence shall have 65 hours for the presentation of its evidence whereas the Lukić Defence shall have 80 hours.

The order further stated that the trial will not sit during the following dates:

- 21 March to 31 March 2008;
- 25 April to 5 May 2008.

DEUXIÈME ORDONNANCE PORTANT MODIFICATION DE CALENDRIER

On 22 November 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54, 65ter, 73ter and 98bis of the Rules, Trial Chamber III ordered that the Prosecution case shall be completed by 24 January 2008 and Rule 98bis oral arguments shall be presented between 28 January and 6 February 2008. The pre-Defence Conference is scheduled to take place on 13 March and the Defence case shall start on 17 March 2008.
