Summary:

When was this particular phrase added to the criminal code, and why? Why did the Legislature remove this word from statute, only to reinstate it the next year? When was the first time the Legislature introduced a bill to legalize sports betting, and what happened that year?

The Legislative Reference Library regularly receives these kinds of questions, and legislative history research can help answer them. But this research process can be time consuming and complex. In this presentation, reference librarians from the Legislative Reference Library break down the process with real-life examples, and outline how research methods and tools vary across years.




