

# Russia Sanctions (Ruselectronics) Designation Notice 2022 (No 14)

## Title

1. This is the Russia Sanctions (Ruselectronics) Designation Notice 2022 (No 14).

## Effective Date

2. This notice comes into effect on the day after it has been notified in the New Zealand Gazette.

## Authority


3. This notice is secondary legislation given under section 11 of the Russia Sanctions Act 2022 ("the Act") by the Secretary of Foreign Affairs and Trade after being satisfied of the matters set out in that section, and has legal effect.
4. This notice is given to assist users of the Russia Sanctions Regulations 2022 ("the Regulations") made under section 9 of the Act, by providing further details of who or what is covered by a description in the Regulations.
5. The description is of the class of persons who are sanctioned under Part 3 of Schedule 2 of the Regulations because they are associates of an entity listed in Part 1 of Schedule 2. The associates and entity are sanctioned by the same regulations.
6. Part 1 of Schedule 2 of the Regulations, *Joint Stock Company Ruselectronics* is sanctioned by regulations 8, 9, 10, 10A and 11.

## Designated Persons

7. The persons identified in Annex 1 of this notice:
  - a. are in the class of persons that are associates of Joint Stock Company Ruselectronics; and
  - b. are designated persons.
8. The Russia Sanctions Register, maintained under section 14 of the Act, will be updated to include these designated persons.

## Revocation

9. This notice is revoked at the close of 17 March 2025.
