Russia/Ukraine: travel bans in response to a military incursion

PURPOSE To seek your agreement to implement travel bans against designated Russian individuals in the event of a Russian military incursion in to Ukraine.

Pito matua – Key points

- Following the Ministry of Foreign Affairs and Trade's (MFAT) 14 February submission 'Russia/Ukraine: Aotearoa New Zealand Response Measures', Ministers agreed that officials should prioritise preparatory work to ensure the Government is able to implement travel bans quickly, and that officials should report back to Ministers as soon as this work is complete.
- In the event of a Russian military incursion to Ukraine, New Zealand is able to implement visa restrictions against targeted Russian individuals. New Zealand imposed travel bans on selected senior Russian officials as well as additional Ukrainian officials in 2014 in response to the invasion of Crimea and Russia-sponsored unrest in Eastern Ukraine. The proposed travel bans would be an expansion of the 2014 list.
- The Immigration Instruction used to implement that decision describes the ban as "**key individuals identified as being responsible for, or associated with, actions which undermine or threaten the territorial integrity, sovereignty and independence of Ukraine**".
- In the event of a Russian military incursion to Ukraine, officials seek agreement to apply travel bans on selected senior Russian officials and military officials responsible for undermining the sovereignty and territorial integrity of Ukraine and for facilitating Russian military action against Ukraine.
- MFAT officials are compiling the names of the individuals to be included. ^{s6(a), s6(b)(i)}

Once the list has been compiled, it will be shared with Immigration officials, who will immediately add warnings to their system. These warnings will raise alerts if any specified officials apply for a visa or otherwise seek to travel to New Zealand. Individuals may be added or removed from the list of travel bans as the situation develops.

- ^{s6(a)} it will be an important way (in lieu of sanctions) to show that we are standing in solidarity with our partners and with Ukraine and make New Zealand's position very clear to Russia.
