Subject: Filling up two (2) posts of Director in NDMC on deputation basis in the Pay Level-12 under 7th CPC Pay Matrix

Sir,

NDMC proposes to fill up Two (2) post of Director in the Pay Level-12, under 7th CPC on deputation basis for a period of three (03) years. As per RRs, the eligibility criteria required for the post are as under:-

- (a) Officers of the Central/State Govts./Uts :-
 - (i) Holding analogous posts on regular basis; or
 - (ii) With five years' regular service in the post in the Pay Level-11 under 7th CPC or equivalent
- (b) Possessing following educational qualifications and experience:-
 - (i) Degree from a recognized university or equivalent.
 - (ii) 10 years experience in administration/establishment/accounts matters.

2. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.

(Similarly deputationist shall not be eligible for consideration for appointment by promotion. Period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications).

4.
