All the HODs are requested to allow the interested employees for participation in the above mentioned games /sports. The Liaison Officers are requested to ensure the discipline by the Players of their department during the Inter-Departmental Tournaments & Annual Sports Meet (Athletics) 2014-2015. Application formats are enclosed with Circular.

With the prior approval of Chairman, NDMC all the participants, who will participate in NDMC Inter-Departmental Tournaments & Annual Sports Meet (Athletic) 2015-16 will be treated on duty during the days of their participation/matches. The Conveners of the concerned event will issue the duty reports to the concerned.

The draw for the Tournaments will be made out by the previous year's Winners and Runners-up who should be placed in different halves/groups so as to avoid any undue strain on the participating team. The losing semi-finalists may also be kept in different halves.

The Sports Committee has rights to change the time, date & venue of the Sports/Games in unavoidable circumstances.

The Competitions will start at 9.30 AM on the dates mentioned above. All participants are to carry individual Identity Cards issued by the NDMC for verification of eligibility criteria at the venue of Tournaments/Games.

The competing teams shall be required to reach the venue/grounds **at-least fifteen minutes before the scheduled time** of play and report to Convener of game. Any team failing to take the field within five minutes after the scheduled time may be scratched.

Referee's decision shall be final and binding on the competing teams. In case of any Team/team walking off the fields of play or not resuming play after the interval, the team concerned shall be disqualified from future participation in the tournament.

Protest, if any, must be lodged in writing with the Jt. Director (Welfare)/Chairman Sports Organizing Committee or Sports Officer within an hour after the completion of the match. Sports Organizing Committee, Convener of the said game & an Umpire/Referee will take the final decision. No protest, however, will be entertained against any decision of an Umpire/Referee except on technical grounds. In all cases, the decision of the Committee shall be final and binding.

Players & Managers of team shall refrain from behavior that may unfairly affect an opponent, may offend spectators or may bring the sport into disrupt, including deliberate damage to equipment, such as breaking the ball or hitting the table with a racket, outrageous language or excessive shouting, deliberately hitting the ball out of the playing area etc, disrespect of match Official and persistent disregard of the regulations prohibiting advice during play. Any act of such misbehavior/misconduct/indiscipline will attract the provision of CCS (CCA) Rules since Employees are treated as on duty during NDMC employees Inter Departmental Tournaments & Annual Sports Meet (Athletics).
