


NOTICE

- i. Consultant (Solid Waste Management) – 01 Number
The applicant should have passed matriculation alongwith SI Diploma.
- ii. Consultant (Ministerial Work) – 01 Number
The applicant should have retired from the post of Section Officer and Head Assistant from the Central Govt./State Govt./Municipal Bodies/NDMC employees and should have graduate and establishment experience.
- iii. Consultant (Environmental Engineer Compost Pit) – 01 Number
The applicant should have master in Environment Engineering/Ph.D. in waste management in Rapid composting technologies with atleast 5 years experience of handling related projects, strong technical and project management skill, knowledge of waste process/treatment technologies especially organic treatment including composting and anaerobic digestion, waste collection techniques, development of inoculums for degradation of waste. The applicant should have functional knowledge of computer.
- iv. Consultant (MIS) – 02 Numbers
The applicant should have expert from NICSII/E-GOV-Consultancy and experience of 03 years for swachhta Cell of NDMC.
- v. Consultant (CBS) – 06 Numbers
The applicant should have passed SO(Accounts)/SAS or equivalent examination and should be retired from the post of Assistant Accounts Officer from Central Govt./State Govt./Municipal Bodies/NDMC and should have atleast 10 years of experience in Accounts and Finance Department with a working experience and in-depth knowledge of duties/works relating to salary, fixation of pay, Income Tax, Internal Audit, Pension pertaining to CCS Rules.
- vi. Consultant (Fire) – 01 Number
The applicant should have retired from the post of Fire Officer cum Nominated Authority from the Central Govt./State Govt./Municipal Bodies/NDMC employees and should have atleast 20 years experience in fire service and in depth knowledge of duties/works related to implementation of fire fighting/fire safety in existing NDMC buildings & in new projects. As the projects have to be approved by Delhi Fire Service (DFS). The applicant shall liason with for getting required NOC/approval in all projects time to time, including smart city projects as per the required rules.
