## Statement

by H.E. Mr. Tran Tuan Anh, Deputy Minister for Industry and Trade, Chairman of National Authority on CWC Implementation at the 19<sup>th</sup> Session of the Conference of States Parties (The Hague 1<sup>st</sup> December 2014)

Mme. Chairperson, Mr. Director- General, Distinguished delegates, Ladies and gentlemen,

At the outset, allow me, on behalf of the Viet Nam's delegation, to express our warm congratulation on your election to the Chairmanship of the Nineteenth Session of the Conference of the States Parties. Mme. Chairperson, Ladies and gentlemen,

Proceeding from the foreign policy of independence, self-reliance, peace, cooperation and development for the prosperity of the nation and the international community Viet Nam actively participated in the activities of the international community to prevent, repel risk of war as well as deal with the consequences of armed conflict and war. Viet Nam joined and strictly observes many conventions, agreements and protocols on disarmament and non-proliferation of weapons of mass destruction.
