Prior to taking up the agenda, the Chairperson condemned the recent attempt on the life of the Prime Minister of Slovakia, H.E. Mr. Robert Fico, and wished him a swift and full recovery. Slovakia thanked participating States for their expressions of support and solidarity. The Russian Federation, Ukraine, Belgium-European Union, the United Kingdom, the United States of America, Türkiye, Canada, Norway, Switzerland, Belarus, Azerbaijan, the Holy See, Poland, Czechia, Germany, France, Lithuania and Latvia expressed their condemnation of the attack and their support for Slovakia.
