

Bill Scored

LD 327, a personhood bill, would have granted legal rights to a fetus which would undermine reproductive rights and create confusion in Maine law. The bill was defeated. A “no” vote is the pro-Planned Parenthood vote.

LD 1237 requires insurance companies to cover up to 12 months of birth control at one time and incorporates the ACA requirement that insurance companies provide copay-free birth control into Maine law. The bill became law; a “yes” vote is the pro-Planned Parenthood vote.

LD 1267 would created a clear approach to public records requests that balances the public’s right for public information with providers’ rights to privacy. The bill was vetoed; a "yes" cote is the pro-Planned Parenthood vote.

LD 1476 ensures Maine insurance plans cover lifesaving preventive care services, as they currently do under the Affordable Care Act. The legislature overrode the governor's bill and it became law; a "yes" vote is the pro-Planned Parenthood vote.

A yes indicates a pro-Planned Parenthood vote; a no indicates an anti-Planned Parenthood vote.
