Subject:      Addition of HRRR and HRRRDAS files to NOMADS/FTPFRD Web  
              Services, Effective February 14, 2024

Effective on or about February 14, 2024 with the 1400 Coordinated Universal Time (UTC) cycle, the National Centers for Environmental Prediction (NCEP) will make an update to the High Resolution Rapid Refresh (HRRR) and High Resolution Rapid Refresh Data Assimilation System (HRRRDAS) data available on NOAA Operational Model Archive and Distribution Service (NOMADS)/FTPFRD web services. The HRRR and 36-member HRRRDAS 1-hour forecast files will be made available for the 0200, 0800, 1400, and 2000 UTC cycles each day, with a 12-hour retention period. This change will affect files on NOMADS/FTPFRD; it will not affect HRRR or HRRRDAS files sent over the SBN.

The file names are hrrrdas\_small\_d02\_YYYYMMDDHH00f01\_mem00XX (36-member HRRRDAS 1-hour forecasts) and hrrr\_YYYYMMDDHHf001 (HRRR 1-hour forecast) where HH is the cycle (02,08,14,20), YYYYMMDD is the year/month/day, and XX is the HRRRDAS member (01-36).
