### **BI-WEEKLY FLOW MONITORING OF AFGHAN RETURNEES**

DATA COLLECTION PERIOD: 16 - 30 NOVEMBER 2023



### **OVERVIEW**

The International Organization for Migration (IOM) in Pakistan collects data on the outflows of Afghans at the Torkham, Ghulam Khan (Khyber Pakhtunkhwa), Chaman, and Badini (Balochistan) border crossing points (BCPs) to better understand the movements of Afghans returning to Afghanistan.

Between 16 and 30 November 2023, 66,662 Afghan nationals returned to Afghanistan, including 33,091 through the Torkham BCP, 30,253 through the Chaman BCP, 2,777 through the Ghulam Khan BCP and 541 through the Badini BCP. In addition, border authorities forcibly returned 9,335 individuals due to a lack of valid documentation. Since 1 January 2023, IOM identified 468,534 returns at the four BCPs, excluding those forcibly returned.

On 26 September 2023, the Ministry of Interior in Pakistan announced its decision to enact an "Illegal Foreigners' Repatriation Plan". The plan comprises of mechanisms to consolidate databases of "illegal foreigners" in the country, check entry of new illegal entrants, apprehension, deportation, repatriation of illegal/overstaying foreigners.

### **HIGHLIGHTS**

- During this reporting period, returns of Afghans have remained high, however, DTM teams have observed a decrease of 61 per cent in returns as compared to the first two weeks of November.
- Eighty-seven per cent of the annual returns in 2023 have occurred since the announcement of the "Illegal Foreigners' Repatriation Plan (IFRP)" on 15 September 2023.
- In terms of push factors, during the current reporting period, 88 per cent of the surveyed returnee families indicated they are moving back to Afghanistan due to fear of arrest. Fourteen per cent also indicated communal pressure as an important push factor.
- During the reporting period, four per cent of the overall flow could be considered vulnerable persons.1 The Displacement Tracking Matrix (DTM) registered 988 returnees moving back to Afghanistan who were chronically ill and require medical attention, in addition to 651 elderly individuals, and 321 persons with disabilities (PWD).






PULL FACTORS (TOP 3) (Multiple answers, N = 4,286, can exceed 100%)




