- ii. the undersigned has complied with any requirements for repayment of aid which the undersigned has received and which, in a previous decision, the European Commission has declared illegal and incompatible with the EU single market;
- iii. the undersigned does not, and will not apply for or receive, with respect to the construction, grid connection and operation of the PV installation(s) covered by this offer, other state aid<sup>2</sup>, support under a German support scheme pursuant to German legislation, or compensation for distributed feed-in of electricity under Clause 18 of the StromNEV<sup>3</sup> or pursuant to other subsequent German legislation.
- iv. that work on the project regarding construction of the PV installation(s) covered by this offer has not started.<sup>4</sup>
