The maps and tables will allow users to see the location and satellite imagery of individual facilities and to click on links providing footnoted wiki pages on each facility. Tracker data will also be provided in spreadsheet format to researchers at nonprofit groups, universities, international agencies, and media organizations. The trackers will be updated twice per year and findings will be publicized in regular reports.
