



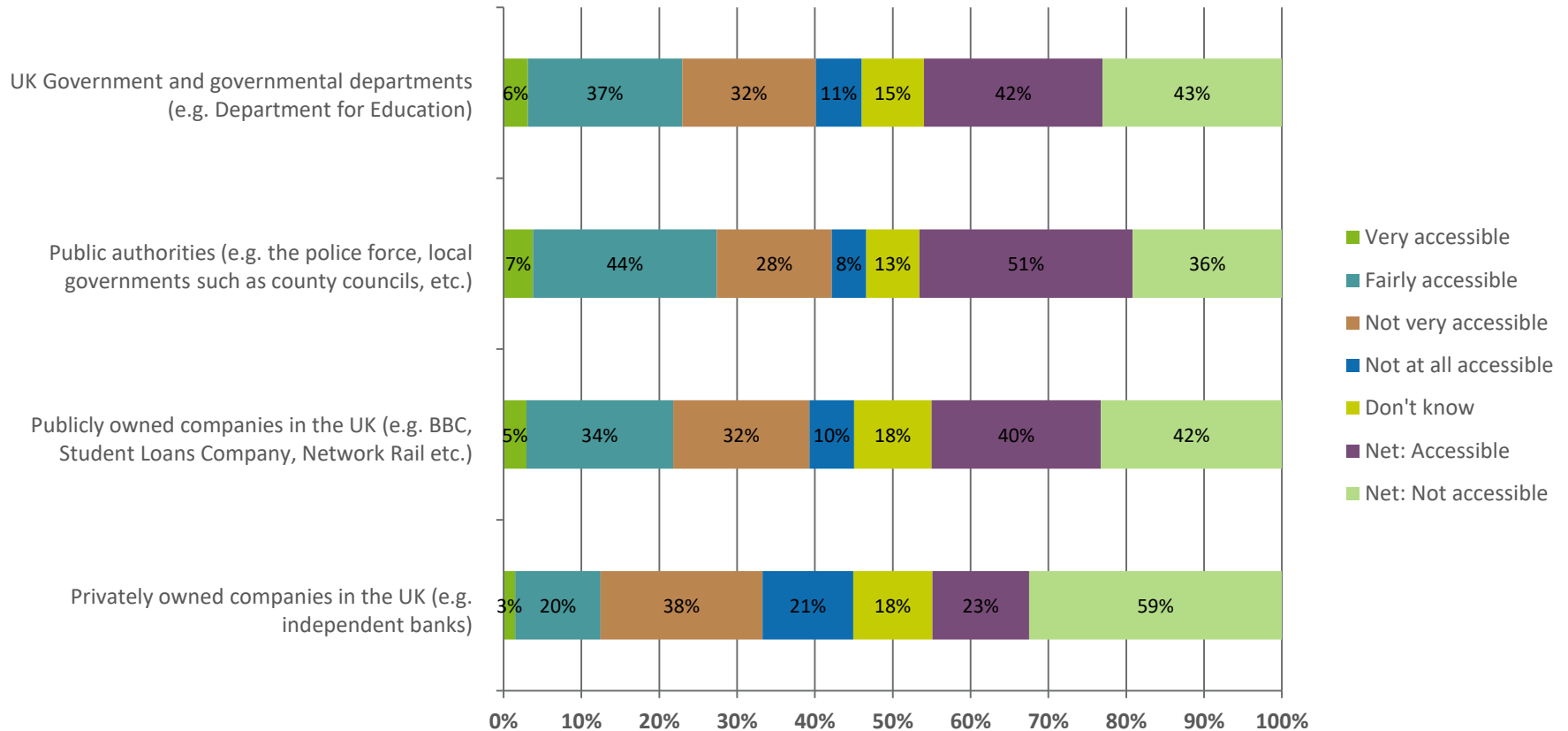

*ECF\_Q1. In general, how accessible, if at all, do you think information about the activities of the following organisations is to members of the public? (Please select the option that best applies on each row)*

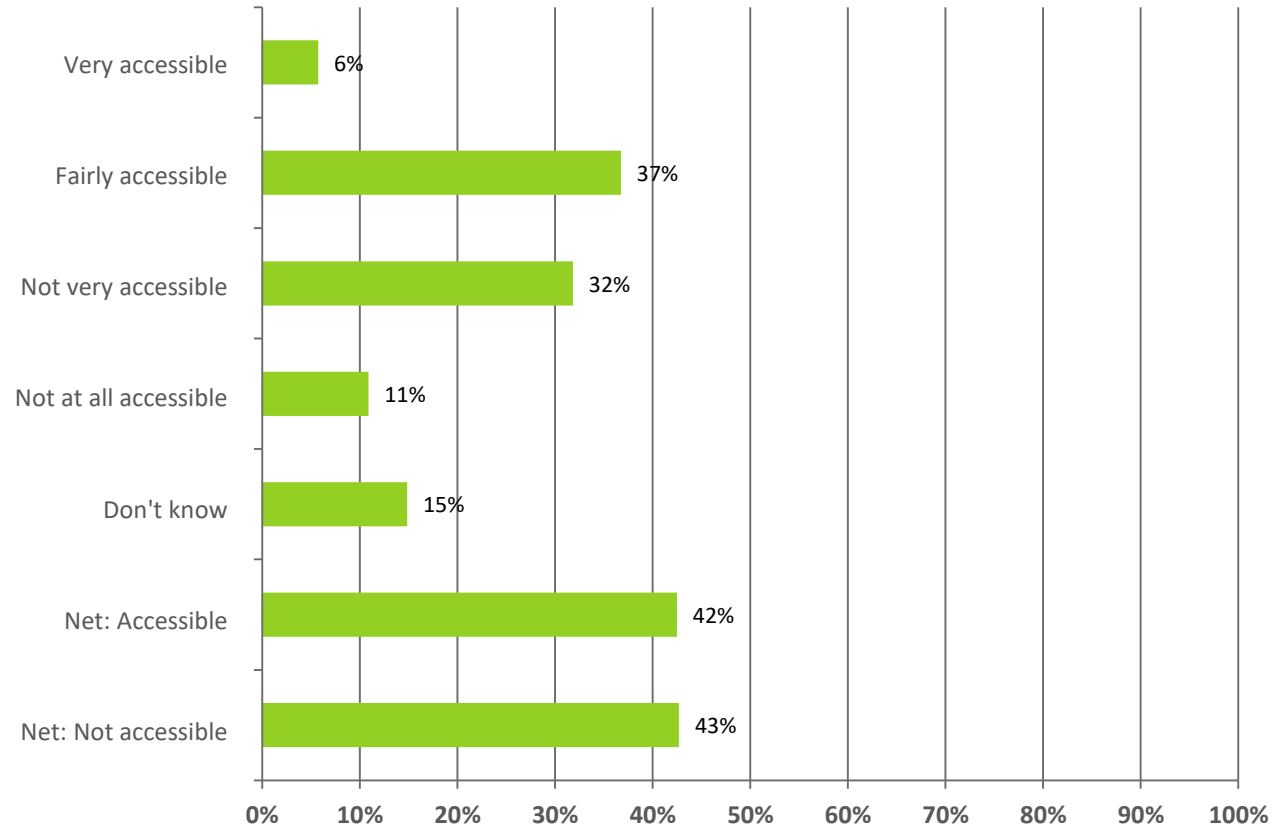

*- UK Government and governmental departments (e.g. Department for Education)*



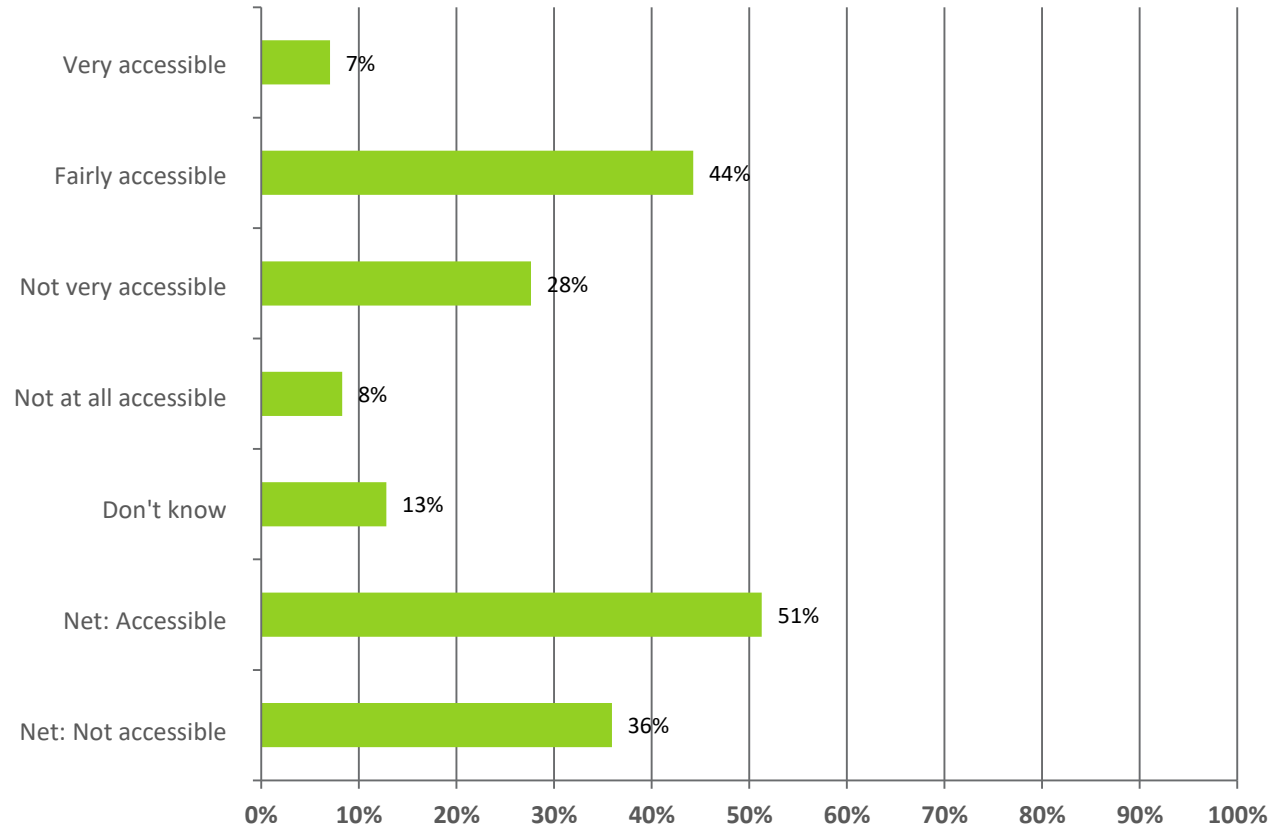

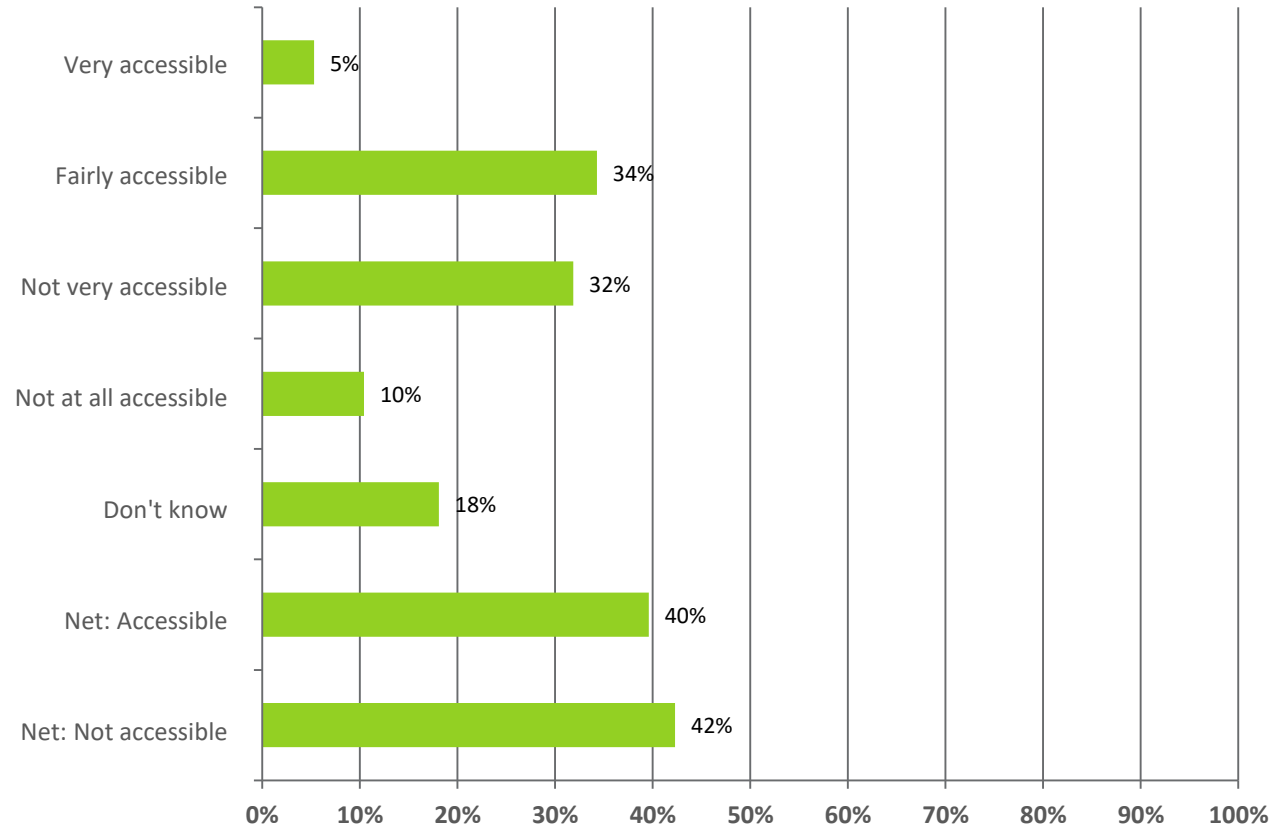

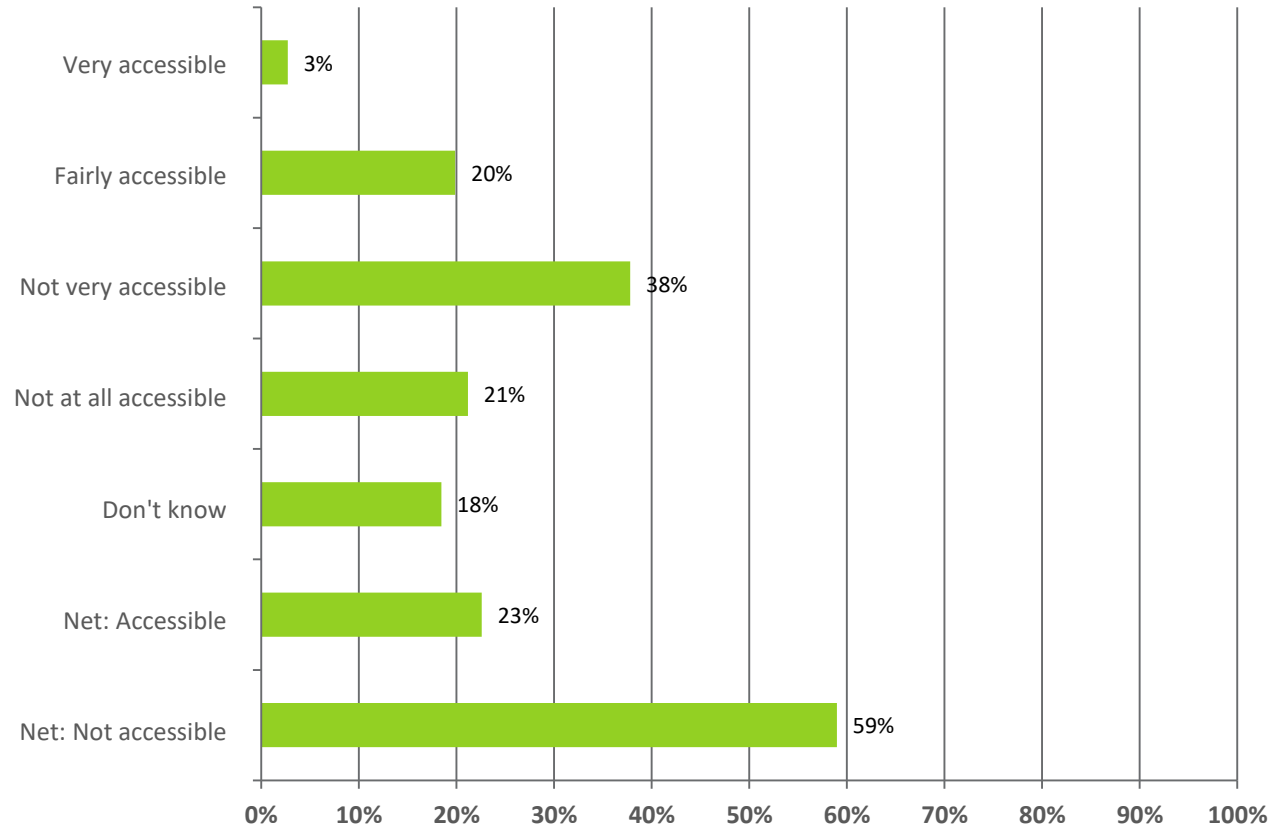

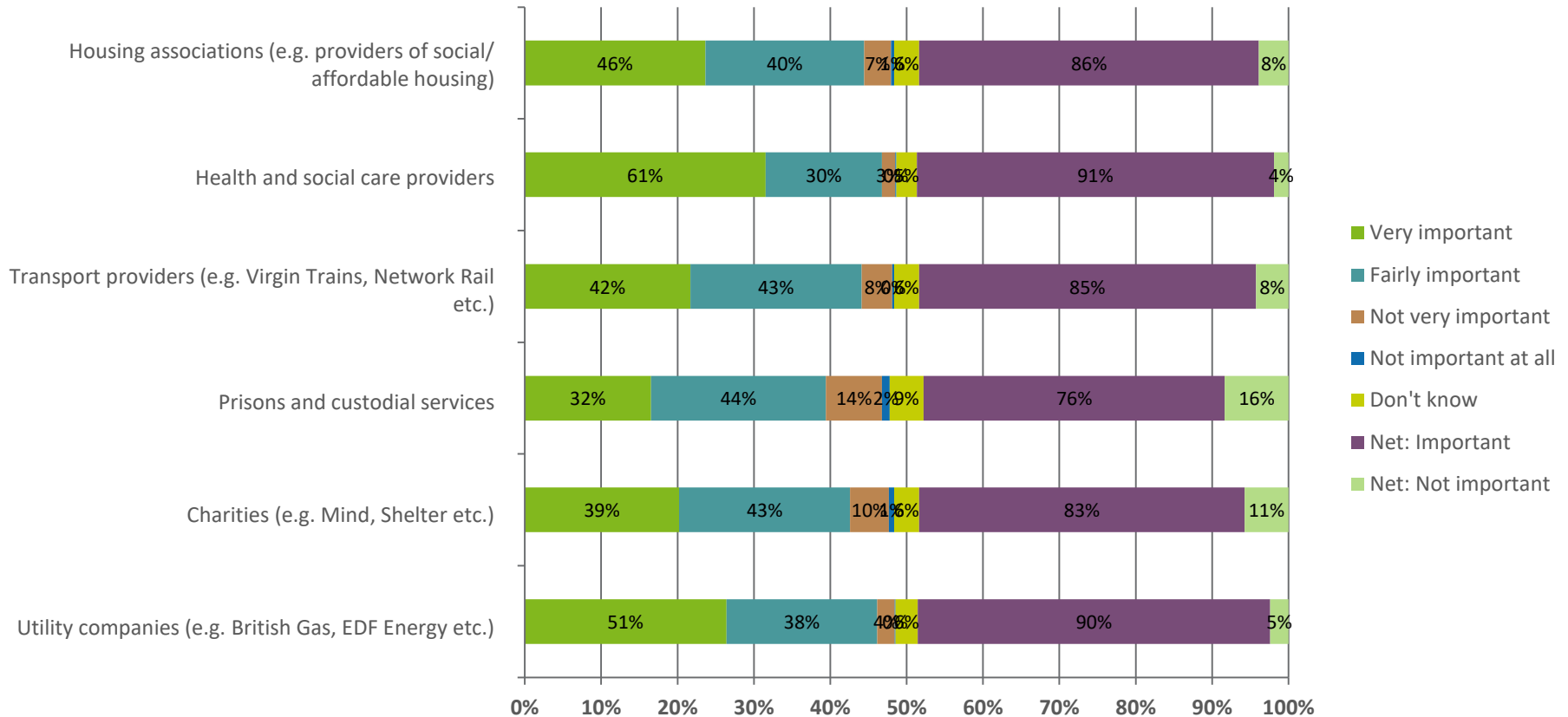

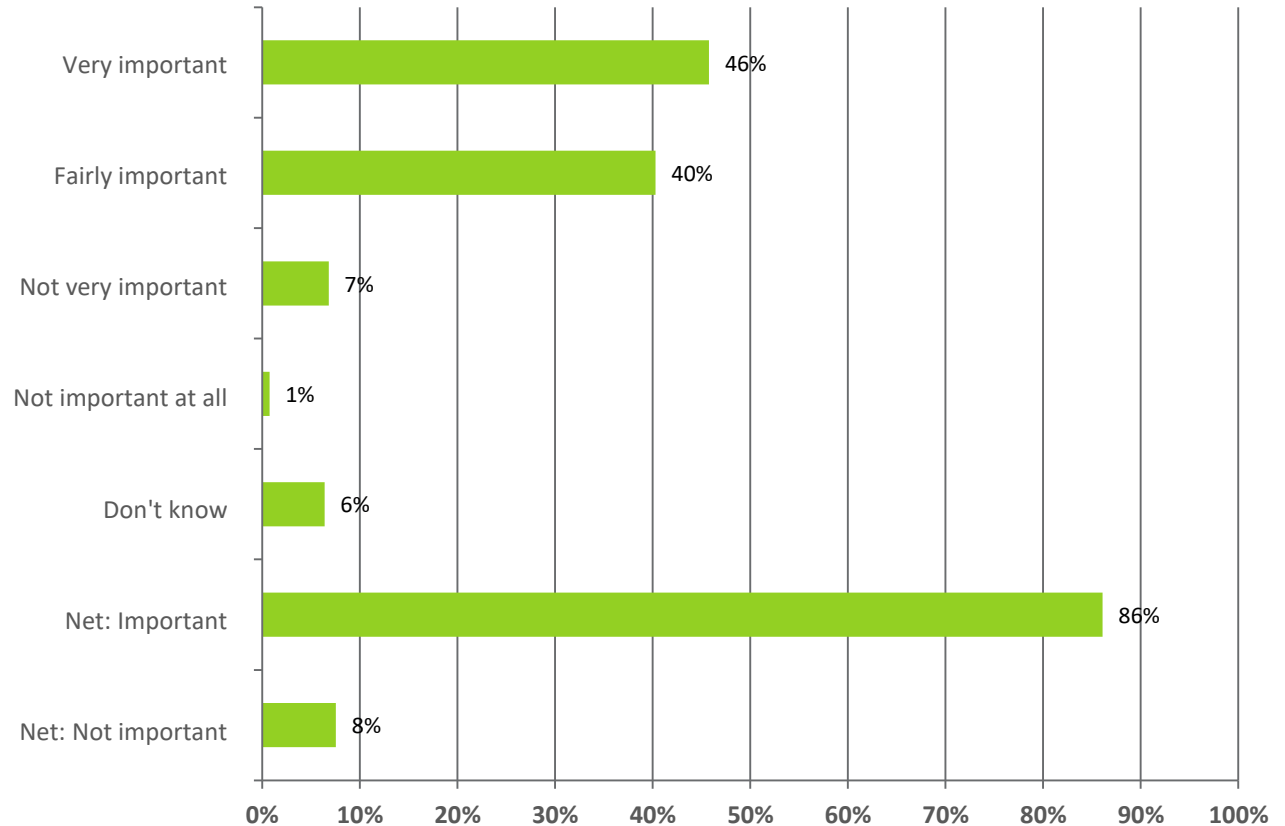

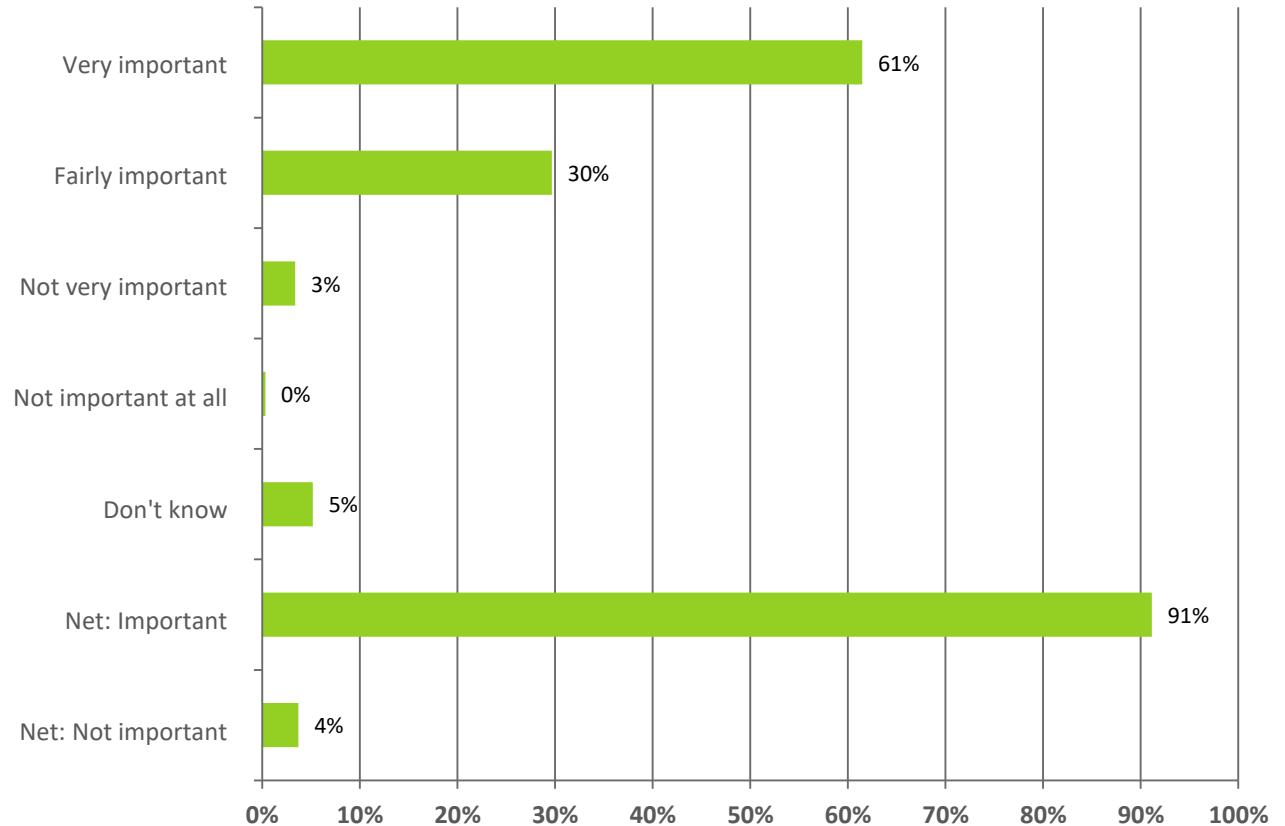

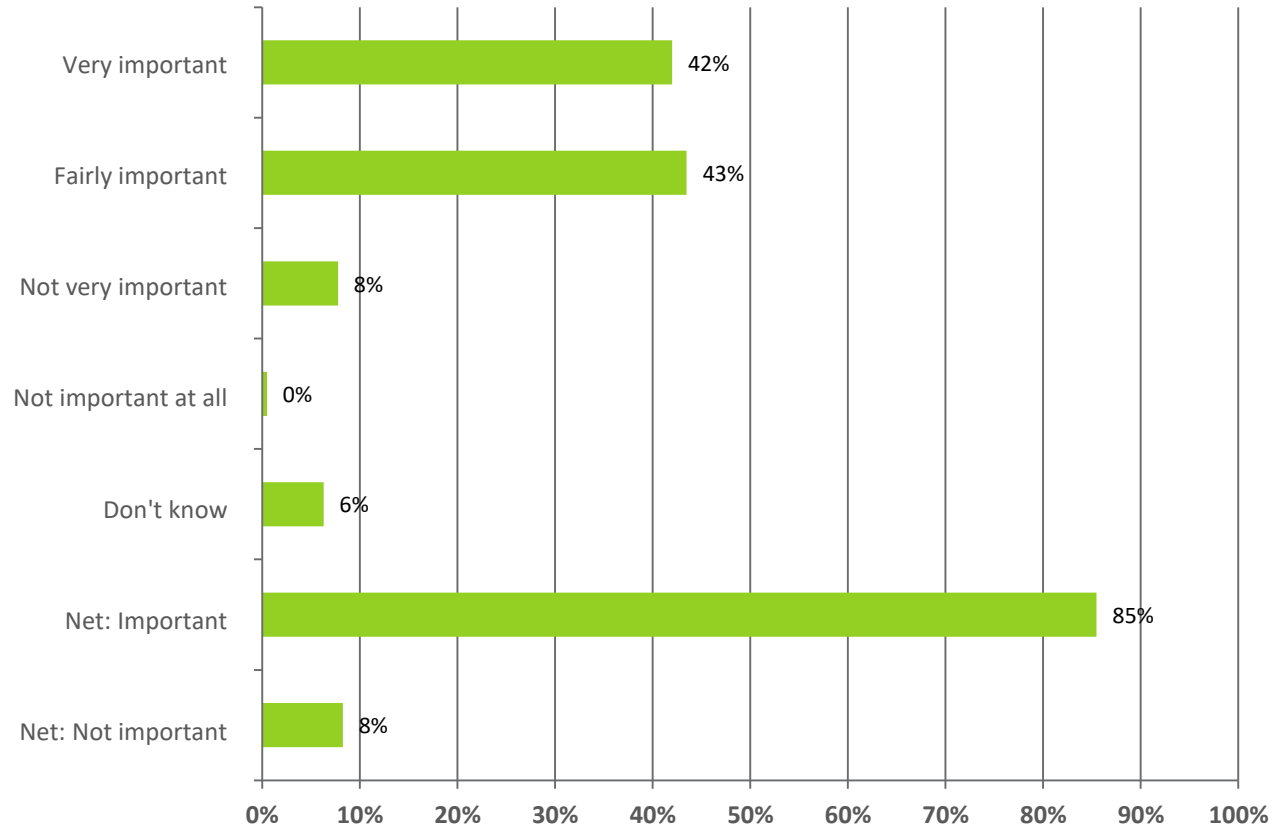

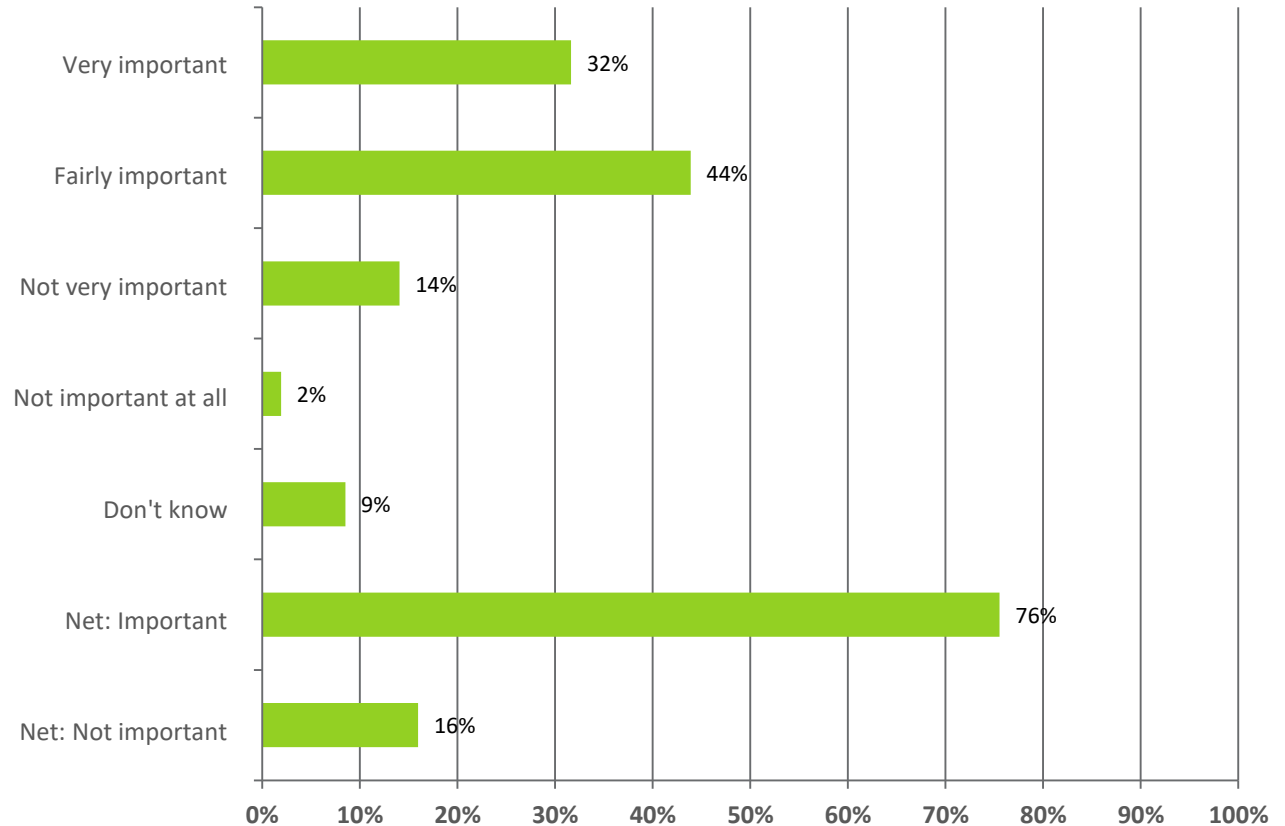

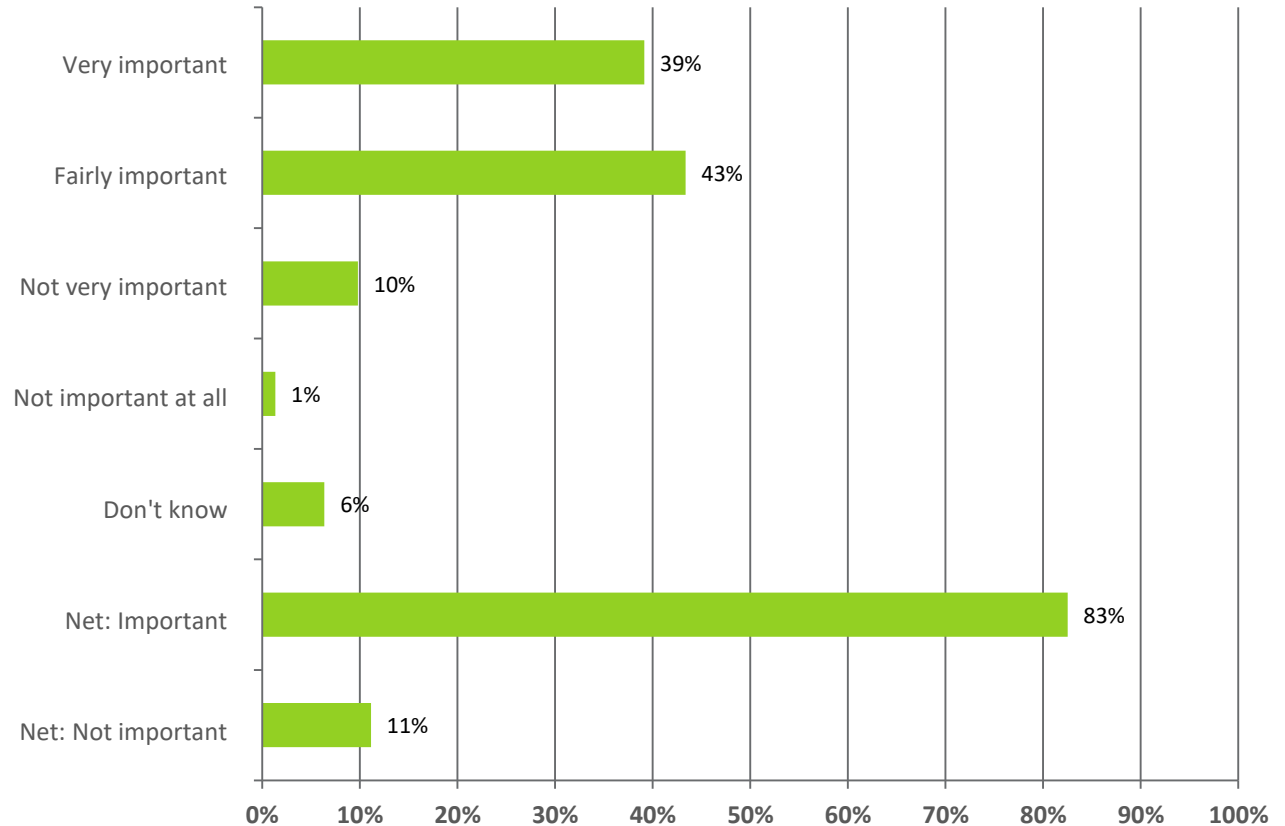

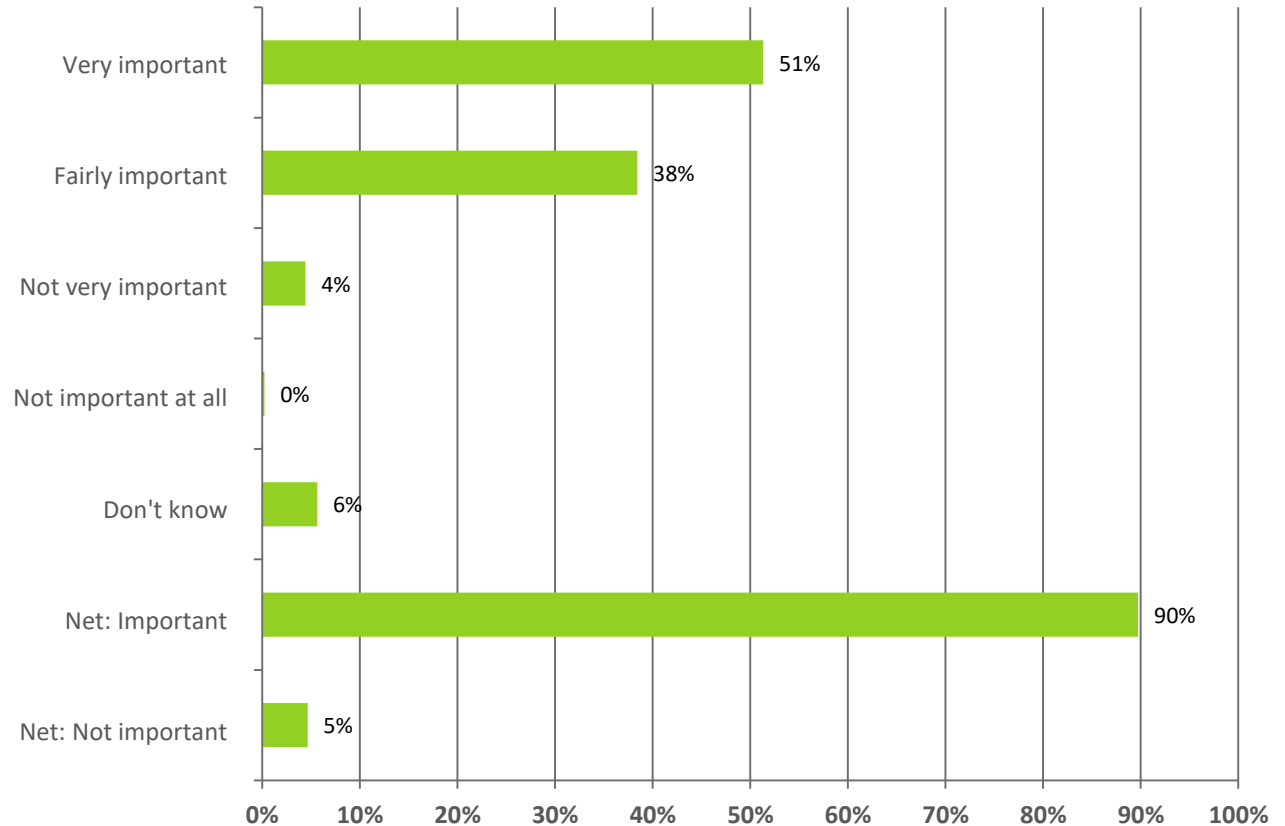

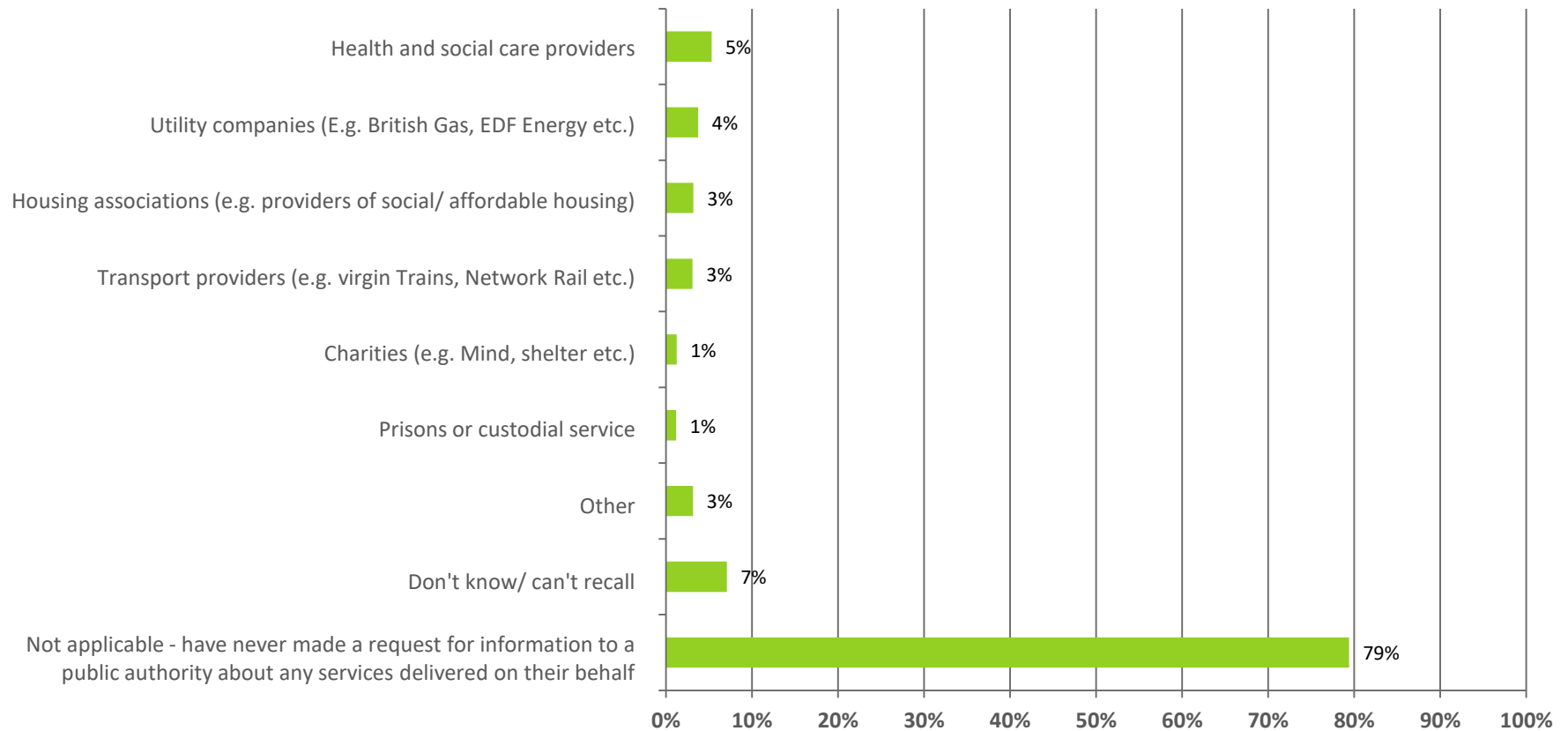

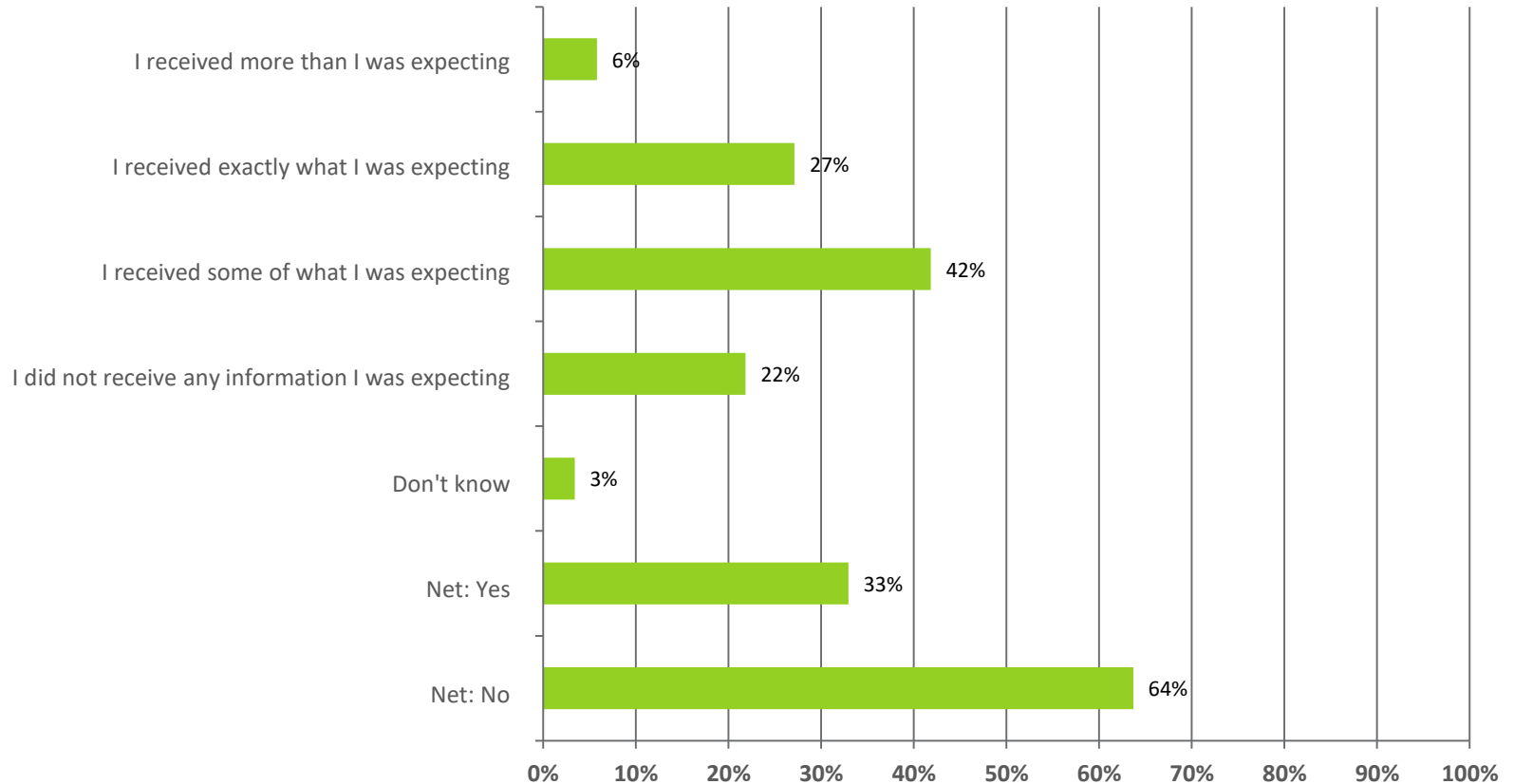
