NFL: Former DB Davis, 35, dead

Former Dolphins and Colts cornerback **Vontae Davis**, who played 10 NFL seasons, was found dead in his South Florida home on Monday, but police say no foul play is suspected.

Police in the Fort Lauderdale suburb of Davie said they responded to a medical emergency at Davis' home Monday morning, but the 35-year-old was dead when officers arrived. No cause of death has been released pending autopsy results. Police said in a statement that the investigation is still active.

● An attorney for Chiefs player **Rashee Rice** said that the wide receiver is cooperating with authorities after a speeding Corvette and Lamborghini sport utility vehicle caused a chain-reaction crash on a busy Dallas highway over the weekend.

● An NFL arbitrator ordered the Cardinals to pay nearly \$3 million to former team executive **Terry McDonough** for making "false and defamatory" statements about him to the media.

● **Carson Wentz** and the Chiefs have agreed to a one-year deal for the former No. 2 overall pick to back up star quarterback **Patrick Mahomes**, per ESPN.

MLB: Dunning, Texas take out TB

Dane Dunning took a one-hitter into the seventh inning and **Josh Jung** homered and drove in four runs Monday night in St. Petersburg, Fla., to lead the defending World Series champion Rangers to a 9-3 victory over the Rays.

● In Oakland, Calif., **Tanner Houck** struck out 10 batters in six scoreless innings and the Red Sox capitalized on five early errors by Oakland to beat the Athletics, 9-0, in front of an announced crowd of 6,618 fans.

● In Baltimore, **Jordan Westburg** hit a tiebreaking, two-run homer in the bottom of the ninth inning to carry the Orioles past the Royals, 6-4.

● In Philadelphia, **Spencer Steer** hit a grand slam in the 10th inning to lift the Reds to a 6-3 victory over the Phillies.

● Baseball players' association head **Tony Clark** nearly doubled his pay to \$4.25 million in 2023, according to the union's annual federal disclosure filing.

NBA: Booker's 52 fuel Suns

Devin Booker scored 52 points to power the Suns to a 124-111 victory over the Pelicans on Monday night in New Orleans, bringing them within a game of the Pelicans for the No. 6 playoff spot in the Western Conference.

● In Chicago, **Vit Krejci** set career highs with 18 points and six 3-pointers, **Bogdan Bogdanovic** scored 20 and the Hawks beat the Bulls, 113-101, in a matchup between potential play-in tournament opponents.

● In Charlotte, **Jayson Tatum** had 25 points and 10 rebounds as the Celtics avenged an early-season loss to the Hornets with a 118-104 victory.

NCAA: Lady Vols ax coach Harper

Tennessee fired **Kellie Harper** as the Lady Vols coach Monday after five seasons.

● **Steve Lutz** was hired as the men's basketball coach at Oklahoma State after one season at Western Kentucky.

● **Andy Enfield**, who had been at USC the past 11 seasons, will lead SMU into the basketball-rich ACC after being named coach of the Mustangs.
