The top-six has remained intact since Jack Roslovic was acquired to slot onto the right wing of the top line next to Chris Kreider and Mika Zibaneiad. The Artemi Panarin-Vincent Trocheck-Alexis Lafreniere unit has been together since Filip Chytil went down 10 games into the season.

Laviolette doesn't foresee any plans to limit the ice time of his top players as part of load management ahead of the playoffs.

"We're playing every other day now," he said. "There's plenty of opportunity for rest. I don't know if somebody going from 22 minutes to 19 minutes is going to be a huge deal. We're going to play the game to win the game. And then we'll get the rest that we need in order to be successful in the next game."

Erik Gustafsson returned to the lineup Wednesday for the first time since absorbing an elbow to the head from the Panthers' Sam Reinhart.

Ex-Knick Flynn drops 50 in loss

Maybe Malachi Flynn should have been the headline player in the Knicks-Pistons trade in February that sent Ouentin Grimes to Detroit and brought Bojan Bogdanovic and Alec Burks to New York.

Flynn, who scored a total of 31 points in 14 appearances with the Knicks after being acquired in the deal that brought OG Anunoby in from Toronto, poured in a careerhigh 50 for Detroit on Wednesday

night in Atlanta — all be it in a losing effort.

Jalen Johnson had 28 points, 14 rebounds and II assists for his first career triple-double to lead the Hawks as they clinched a berth in the Eastern Conference play-in tournament.

Flynn, whose previous career high was 27, was 18-for-25 from the floor and 9-for-12 at the line. The 50 points was a franchise record for a reserve. He also had a season-high six rebounds, five assists and five steals in 34 minutes.

The Pistons have lost 10 of their last 11 games.

"Right now, its tough because at the end of the day you want to win," Flynn said. "But it does feel good to kind of take in the moment. I'm sure a couple of days from now, it will feel really good."

Flynn said it was the first time he scored 50 at any level.

"I almost did in high school. I had 49 and my coach took me out. I still have a grudge," he said, according to The Athletic.
