This funding supports direct awards to UNICEF, WHO, and additional activities such as embedding of CDC's polio subject matter experts, technical support, and world reference laboratories. In FY 2021 and 2022, USAID's polio eradication appropriations totaled US\$ 140 million. This funding is directed towards supporting WHO and UNICEF for disease detection and communication activities; as well as support to a network of non-governmental organizations (NGOs) for community-based programs that focus on surveillance and social and behavior change. USAID also provides technical surge staff and subject matter experts.
