This ward is losing the people who make it so special. Our ward, and particularly the neighborhoods of Avondale and Albany Park, have come under a gentrification threat, and our alderman is working closely with big developers to push longtime residents out of the ward; I believe there is an urgency to this issue. My relationships with the people of the neighborhood, my experience organizing in our community to address these issues, and my personal story as someone who has dealt with many of the challenges facing ward families, including coming to Chicago from somewhere else (our ward has a very large immigrant population), gives me a perspective that the other candidates do not have. Representation matters, and so does engaging the many people in the ward who have a great deal at stake in our ward's future but are not being adequately involved in the process. Our ward is majority Latinx, and if elected, I would be the first Latinx alderman to represent the 33rd Ward.
