HSC Deputies Meeting
May 6, 2004**

Purpose

To update the Deputies on the status of (1) the FEMA/OLC effort to update Presidential Emergency Action Documents (PEADs), and (2) the request for Departmental compilation of individual department and agency emergency legal authorities.

Background

PEADs are pre-coordinated legal documents designed to implement a Presidential decision or transmit a Presidential request when an emergency situation disrupts normal governmental or legislative processes. There are presently 48 PEADs with supporting documents. The PEADS portfolio needs to be updated now. The Department of Homeland Security is presently coordinating the review and updating of PEADs throughout the Executive Branch. FEMA is the Executive Secretariat for that effort, which is being undertaken in conjunction with the assistance of the Office of Legal Counsel (OLC) at Justice.

Discussion

I. PEADs: FEMA conducted a kick-off meeting on the PEADs update project on April 22, 2004. Departments and agencies were tasked to review, update and/or generate new PEADs, and to submit a review plan for how those tasks will be accomplished. Departments and agencies are also being asked to prioritize the PEADs for which they have primary or supporting responsibilities, so that appropriate resources may be directed to the most critical areas.
