### Visibility

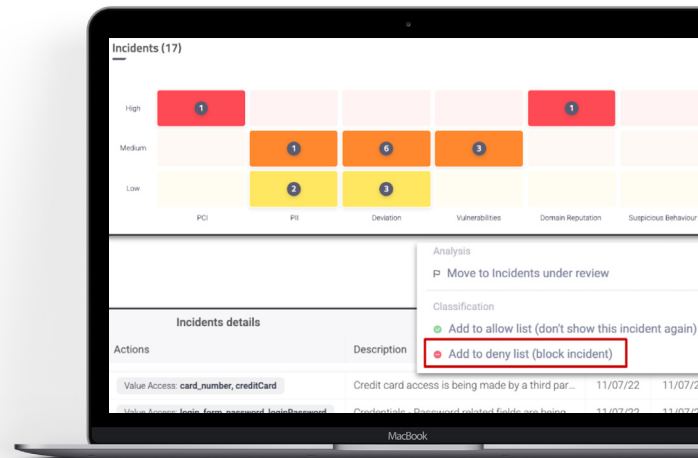

These insights identify high-risk PII, PCI DSS and vulnerability incidents, so response teams can act fast.

### Mitigation

Using behavioral analysis and advanced machine learning, Client-side Defense identifies script vulnerabilities and anomalous behavior to enable and maintain compliance. The solution provides comprehensive client-side mitigation, including:

- Granular control over legitimate JavaScripts to restrict form access without disabling the entire script
- Content Security Policy (CSP) management to block unwanted scripts from loading entirely

### COLLECT

The HUMAN Sensor runs in the consumer's browser to automatically inventory each script, assure script integrity, and inform authorization decisions based on actual script behavior.



### ANALYZE

The Sensor detects unauthorized changes, alerts on anomalous behavior, and responds by surgically blocking undesired actions, without interrupting desired script activity.



### MANAGE

The cloud backend and UI provide not only visibility, intelligence, and one-click mitigation, but also evidence of compliance for on-demand audit reports.
