Message from Executive Director

The Future of Syria and The Region

The response to the Ukraine crisis has been tremendous. The solidarity shown by governments and citizens across Europe and further afield towards those fleeing from the crisis in Ukraine is commended. The commitments at the High-Level International Donors' Conference for Ukraine in Warsaw on Thursday (5 May) are another testimony of the solidarity to Ukrainian people. The decision by the EU to apply the temporary protection directive to people leaving Ukraine provides the necessary legal safeguards on status and shows that together it is possible to uphold commitments to international refugee and human rights law.

Watching European nations open their minds and arms to millions of Ukrainians, we can't help but compare the fates of the 12 million Syrians that have been uprooted by war.

As with the five previous editions, the sixth Brussels Conference on Supporting the future of Syria and the region (9-10 May) will also address the most critical humanitarian and resilience issues affecting Syrians and communities hosting refugees from Syria, both inside the country and in the region. The conference is expected to renew the international community's political and financial support for Syria's neighbors, particularly Jordan, Lebanon and Turkey, as well as Egypt and Iraq. The conference is a vital opportunity to emphasize on the important role of the different civil society organisations in rebuilding their country, and in getting equally included in the dialogue to achieve a lasting and prosperous peace process.

Once the war finally comes to an end in Syria, acknowledging that the conditions for voluntary, safe and dignified returns are not yet met, the challenge is on rebuilding the country. Who will foot the bill remains an open one? While the destructive impact of 11 years of war in Syria is clear and present, to what extent does Russia's invasion of Ukraine have an impact on the engagement from Western Nations?

As we approach Europe Day, on 9 May, a day to remember peace and unity after the horrors of World War Two, we are also to aspire for an engine of solidarity to deal with the humanitarian and economic fallouts well beyond Europe.

Forced Migration

4. Meeting on The World Bank Group's 2023 World Development Report

On 4 April, InterAction and ICVA organised an online meeting with the World Bank Group, to discuss the World Bank's World Development Report for 2023, which intends to focus on cross-border mobility of refugees and migrants. Gathering thirty NGOs, this event was an opportunity to exchange views with Mr. Xavier Devictor, Co-Director of the 2023 World Development Report, on the framework of the report, as well as the key issues and messages that could be included. Follow-up discussions and opportunities for ICVA members to engage on this topic will be organised in the coming months.

5. Third Country Solutions Strategy Workshop

On 21-22 April, ICVA's Head of Forced Migration joined a multi-stakeholder Third Country Solutions Strategy Workshop convened in Geneva by UNHCR's Resettlement & Complementary Pathways Service, Division of International Protection. Following the completion of the [Three-Year Strategy on Resettlement and Complementary Pathways](#), as well as consultations held last year, this workshop intended to lay the foundations for a successor process for continued focused actions to increase third-country solutions. Further information on this process will be shared in June, at the [Annual Tripartite Consultations on Resettlement \(ATCR\)](#). In line with its longstanding engagement with the Global Compact on Refugee and its solutions focus, ICVA will continue to contribute to this process.

6. UNHCR Quarterly Consultations with NGOs

On 27 April, UNHCR and ICVA co-organized the second [UNHCR-NGO Quarterly Consultations](#) of the year on "Co-designing UNHCR-NGO Recommendations on Localization and Climate Action". With insights from [Internal Displacement Monitoring Center](#), [COHERE](#), and [UNHCR](#), the objective was to present a set of preliminary recommendations for the [UNHCR Global Consultations with NGOs](#). Several feedbacks received during the meeting will feed into the document, which will be finalized on the basis of the June Global Consultations. Notes on this second Quarterly Consultation will soon be disseminated to participants.

Coordination

10. Ukraine Response: Coordination Support for NGOs

ICVA continues to contribute to the strengthening of NGO coordination in the Ukraine response through the deployment of NGO Coordination support for the response, as well as through partnerships with national NGO leaders. The humanitarian response continues to be scaled up, and NGOs must adapt to the changing situation with ongoing efforts supported by ICVA to improve NGO understanding and engagement with various coordination mechanisms, including the pooled fund. Support is also needed to strengthen collaboration between NGOs and to work towards improved advocacy and localization efforts in the response.

11. Saving Lives Together

ICVA joined the [Saving Lives Together](#) Oversight Committee meeting to discuss the ongoing commitment and engagement of both UN and NGO partners towards this initiative to enhance security collaboration between the UN Security Management System (UNSMS) and NGOs. The meeting highlighted the need to collectively understand and collaborate in addressing the impacts of security threats to support the safe delivery of humanitarian assistance. ICVA is currently seeking a new member representative to join the SLT Working Group and support ongoing implementation of the framework, please contact jeremy.wellard@icvanetwork.org for more information.

12. Inter-Agency Standing Committee (IASC)

The IASC Principals

The ERC convened on 14 April an ad hoc IASC Principals meeting to discuss the situation in Ukraine. He briefed on his recent visits to Moscow and Kyiv as part of the efforts to explore agreements for humanitarian pauses and corridors. The follow-up actions of the meeting include to strengthen the scale-up assistance, including by empowering and providing assistance through local partners, where possible and to sustain operational focus and advocacy on other crises beyond Ukraine, including by increasing advocacy and attention to the secondary impacts of the crisis.

Operational Policy and Advocacy Group (OPAG)

OPAG convened on 26 April to discuss the findings and recommendations of the IASC commissioned independent “Review of the implementation of the IASC Protection Policy.” The Review, which was conducted by the Humanitarian Policy Group (HPG) at ODI, reflects input of 700 people, including feedback from IASC members. It reaffirms the importance of the centrality of protection. It also identifies barriers and blockages and makes recommendations for how the humanitarian system could address them and bring about real change as the protection risks of ongoing crisis are significant. The drafters of the Review presented the main findings and recommendations followed up by a discussion with OPAG members. The finalised Protection Policy Review report is planned to be presented to IASC Principals and the IASC is expected to agree a management response to guide future action.

13. NGO Fora Support Programme:

ICVA is setting up the next phase of the NGO Fora Support Programme. The NGO Fora Support Programme includes a centralised support desk function, small grants to NGO Fora and a series of exchange workshops for NGO Fora staff.

14. Address COVID-19 Vaccine Inequity in Humanitarian Settings

On 26 April, ICVA held an online workshop on COVID-19 vaccination in humanitarian settings. ICVA members and local partners from Sierra Leone, DRC, Yemen, Lebanon, Nigeria, South Sudan and HQ joined the discussion around barriers, opportunities and emerging best practices on COVID-19 vaccination response. Key emerging recommendations included: a) the need to embed NGO participation in planning and decision-making on response instruments from the global to the local level and b) health systems must be strengthened and mainstreamed.

The Global Health Cluster COVID-19 Task Team focal point presented a landscape overview highlighting the continued importance of COVID-19 vaccination as it remains a [Public Health Emergency of International Concern](#). In low income countries just 8.4% of the 565 million people eligible for vaccination are fully vaccinated.

ICVA exchanges regularly with the [COVAX Vaccine Delivery](#) partnership led by Ted Chaiban, which is the key mechanism for resolving vaccine inequity in humanitarian settings. The CoVDP was established in December 2021 to help countries reach the 70% WHO COVID-19 vaccination coverage target. The CoVDP is targeting 34 countries, over half of whom are managing significant humanitarian needs and refugee populations. The CoVDP partnership welcomes interested NGOs and humanitarian agencies to engage with their Country teams and in their micro-planning, and is making funding available for NGOs to support COVID-19 vaccination in humanitarian settings.

15. Champion Principled Humanitarian Action

Civil Society 7 Summit

ICVA along with Action Against Hunger Germany Co-ordinated the Humanitarian Assistance and Conflict Working Group for the Civil Society 7 summit that was held in 4-5 May. The group included over 40 representatives of NGOs globally including a number of ICVA members. The working group met throughout March and April in developing the proposed [five concrete recommendations](#) to the G7. At the Civil Society 7 Summit the Working Group presented the recommendations and led a Roundtable on 'Closing the Gap: Between early warning and anticipatory humanitarian action' with contributions by the Somalia NGO Consortium and the Start Network.

ICVA also engaged in the Climate and Environment Justice Working Group for Civil 7. The Working Group purposes to ensure that the mandatory measures and concrete actions of the Paris Agreement as well as the Sustainable Development Goals are ambitiously pursued and implemented by G7 governments.

ICVA and PHAP Webinar - Understanding and Integrating Climate and Environment Risk Data in Humanitarian Action(28 April 2022)

The webinar was held on 28 April and speakers shared insights on:

- Operational implications of using data supported evidence in policy and for decision-making and programming – early warning, early action, preparedness and effective response to limit displacement
 - Challenges, opportunities and ways forward for the humanitarian system on incorporating climate/environment risk into needs analysis, programme design and implementation
 - Access to data and data availability to local and international actors to minimise the climate risks to most vulnerable populations

Child Rights

2022 Virtual Annual Meeting of the Alliance for Child Protection in Humanitarian Action

This Annual Meeting will be held virtually on the 20 - 22 June under the theme, Promoting the Centrality of Children and their Protection in Humanitarian Action through Accountability, Localisation and Working Across Sectors. The meeting represents a forum to drive discussions on the transformation of the [Alliance strategy](#) into a concrete and ambitious strategic plan. [Register now](#).

ICVA participated to the event '15 Years of the Paris Principles and Commitments: lessons learnt and ways forward for the implementation of action to prevent child recruitment in armed conflict and support reintegration' on 4 May 2022

As 112 States have endorsed by now the Paris Principle, this event, co-organised by the International Committee of the Red Cross, the International Labour Organisation and Save the Children, offered the opportunity to hear a range of perspectives on the progress made and challenges faced to end the unlawful recruitment and use of children associated with armed forces and armed groups and to ensure that children are successfully reintegrated into their families and communities.

Gender

ICVA Secretariat joined the [Call to Action on Protection from Gender-Based Violence in Emergencies](#). The Call to Action is a multi-stakeholder initiative launched in 2013 to fundamentally transform the way gender-based violence is addressed in humanitarian emergencies. The aim is to drive change and foster accountability so that every humanitarian effort, from the earliest stage of a crisis, includes the policies, systems and mechanisms to mitigate gender-based violence risks, especially violence against women and girls, and to provide safe and comprehensive services to those affected by gender-based violence.

ICVA commitments relate to the Call to Action Outcomes on Advocacy and Localisation:

- Advocate for implementation of system-wide and institutional policies and capacity to address GBV, strengthen gender equality, and ensure accountability, including in key strategic humanitarian documents.
- Support local actors, particularly women's organisations, to lead and engage in GBV coordination and on gender equality coordination, and in Humanitarian Country Teams, pooled fund steering committees, and other relevant humanitarian architecture.

27 ICVA members have joined so far the Call to Action. We encourage all to follow suit.

A Scoping Study – What Role Should ICVA Play in Enhancing Member’s work on Gender in Emergencies?

20. Africa

The Fourth (4th) Ordinary Session of the Specialised Technical Committee (STC) on Migration, Refugees and Internally Displaced Persons

In Advance of the African Union's (AU) Humanitarian Summit which will be held in Malabo Guinea, the AU held the experts session of the Specialised Technical Committee on Migration, Refugees and Internally displaced persons. The meeting focused on validating an important legal instrument that will contribute to the operationalization of the African Humanitarian Agency, Migration governance within and outside the continent and several policy documents that will enhance effective governance of migration, refugees and IDPs issues in the continent as well as a progress report on the implementation of the Protocol on Free Movement of Persons in Africa. The Meeting will also prepare for the Humanitarian Summit and Pledging Conference that will take place from 25 – 27 May in Malabo, Equatorial Guinea.
