U.S. National Pharmacy Market Summary 2021

Market Insights Report



Introduction

Tracking changes and trends in pharmacy growth, personnel, ownership, and many other data points have become essential for understanding the healthcare market at large. Pharmacies have adapted their businesses in response to the pandemic by supplying COVID-19 testing and vaccines.

TRENDS

Like all healthcare segments, pharmacies have been impacted by COVID-19. According to IQVIA data on weekly mail order prescriptions during the summer of 2020, there was an average increase of 6.5% over the same period in 2019 as consumers embraced mail order. Mail order prescriptions had been on the decline until the COVID-19 pandemic reversed the trend.

Beginning in April 2020, IQVIA's National Health Care Utilization Project showed that elective procedures nearly ceased. Between March 6, 2020 and May 29, 2020, the use of prescription drugs was down 34%, pharmaceutical usage was down 41% for acute therapies, and 23% for chronic therapies. The dramatic fall in the amount of people starting therapies or adding drugs to their regimens negatively impacted prescription sales throughout the United States.

PHARMACY COUNTS

As of August 2021, Walgreens led the pharmacy market in number of pharmacists, however, CVS led by number of locations. CVS placed second in the number of pharmacists while Walgreens place second in the number of pharmacies. Walmart placed 3rd in both the number of pharmacists and the number of pharmacies. The top five pharmacy corporations own over 29,000 retail locations with CVS and Walgreens accounting for over 10,000 and 9,000 locations respectively. In fact, 88% of all pharmacy facilities are retail locations.
